NRAEF's ProStart serves about 118,000 students at over 1,700 high schools in 50 states, Guam and at Department of Defense Education Activity schools in Europe and Asia. Additionally, the NRAEF awards scholarships to students and educators to provide continued industry education. Since 1997, the NRAEF has awarded more than \$21 million in scholarships.
